Short term notice inviting tenders/ rates for cultural nights during State Level Nalwar Mela 2026 for Star Artists, Live Playback Singers, (Punjabi, Hindi, Pahari), Comedian, Laughter Artist, Acrobatic Artist, Foreign Troupes and Dance Troupes.

This is to inform all concerned that the State Level Nalwar Mela - 2026 will be held in Sundernagar w.e.f 22/03/2026 to 28/03/2026. During this Mela, Cultural programme will be held in the evening w.e.f 22/03/2026 to 26/03/2026 in which various artists like playback Singers, Comedians, Punjabi Singers, Qawali/Sufi Singers, Group Performance, Acrobatic Artists, Foreign Troupes, Dance Troupes and other stage performances etc are proposed to be held.

The expression of interest/ proposal in sealed envelopes is hereby invited from all the interested Parties/ Event Managers so as to reach the office of the undersigned on 28/02/2026 till 12.00 PM. The same shall be opened in the presence of interested parties on the same day at 2.00 PM. The following terms and conditions shall apply:

**GENERAL TERMS & CONDITIONS:**

1. The rates should be quoted for only those artists, whom the bidders have been/are able to bring at any State/ National/ International Level Cultural Nights in the previous 5 years or Artists who fall within the same range of rates and can be brought by the bidders for the Nalwar Fair Cultural Nights.
2. The Technical bid and financial bid in separate covers duly super scribed as "Technical Bid for Cultural Nights" and "Financial bid for Cultural Nights" and both the Technical and Financial bids to be put in a large envelope duly super scribed or written on the top as "Tender for Cultural Nights" and properly sealed.
3. The rates to be quoted by the bidders in the financial bid shall be written in figures and in Words.
4. If in the event of rates quoted by more than one bidder in a financial bid happens to be the same, rates will be negotiated with all the bidders. The decision for calling any of the L-1 first for negotiations is reserved with the undersigned.
5. The Tenderer /parties shall furnish a FDR/DD of R\$. 50,000/- (Fifty Thousand ) duly pledged in the name of Chairman, State Level Nalwar & Suket Devta Mela Committee Sundernagar on account of performance money deposit. This EMD shall be converted into performance security in respect of successful tenderer, which will be returned to successful tenderer after completion of Nalwar Fair. FDR/DD of 2nd and 3rd bidder shall be returned after closing of Nalwar Fair- 2026. The tender received without EMD shall be rejected straight away.
6. The interested parties/ event managers should have the experience of organizing such events at least in Two international and Two National/State fairs events organized by the Government during the last five years.
7. Copy of ITR or any other document duly certified by Chartered Accountant which certifies the Average turnover during three years out of previous three to Five years.

8. The rates for each artist/ performer shall be quoted for each performance. The quoted price shall be inclusive of all taxes. Performance rate quoted for Sundernagar.
9. No. overwriting on the rates will be accepted. Rates written against the artist will be cancelled, and will not be considered even if it happened to be the lowest.
10. Participating bidders are intimated that rates should only be quoted for artists/ performers whom they are able to get for the Festival. Each bidder shall be bound to confirm the participation of the artist/ performer for whom he/she quotes the lowest rates if the Mela Cultural Sub-Committee selects such artist/ performer for the Festival. In case a bidder quotes the lowest price for an artist/ performer selected by the Mela Cultural Sub Committee but he/she is not able to confirm the participation of the artist/ performer at the rates quoted by him/her, then the Mela Cultural Sub-Committee reserves the right to forfeit their earnest money deposit for the default in performance.
11. Quotations should be submitted only on the official format for bid, The bidders should write "Quotation for Star Artists for Nalwar Fair- 2026" on the sealed envelope.
12. It shall be the discretion of the Mela Cultural Sub-Committee to select artists/ performers from the artists offered by the bidders or out of the list of artists in bids.
13. Negotiation shall be held with the Parties/ Event Managers for the artists shortlisted by the Mela Cultural Sub- Committee.
14. The interested Parties/ Event Managers, whose rates are accepted for a particular artist, shall have to deposit 25% of the total amount accepted for the particular artist with the Mela Committee in the form of demand draft in the name of **Chairman (SDM) State Level Nalwar Fair Sundernagar**. which shall be released after satisfactory performance of the artist/ performer.
15. The Successful bidders have to submit it an acceptance letter within one day of the artist finalized for performance on the scheduled date in Nalwar Cultural Night from the Artist's official email <http://www.sundernagarnalwar.com>.
16. No advance payment shall be made to the concerned party. 100% payment shall be released after the satisfactory performance of the artist.
17. The 25% amount deposited as security with the Chairman, Nalwar Mela Committee shall stand forfeited in case the concerned party fails to arrange the artists/ performer as desired by the Mela Committee. He /She will also be black listed for participating in the bidding process of future Melas .
18. The concerned party/ event manager shall have to enter into a written agreement with the Mela Committee.
19. That in view of unforeseen circumstances or any decision, the Nalwar Mela Committee compelled to shift the venue, time of the show then the successful bidder shall provide the same service on the venue and time fixed by the Nalwar Mela Committee.
20. If any of the dates mentioned above happens to be a holiday, the quotations shall be received and opened on the next working day at the same time.
