Office of the **Sub Divisional Magistrate –Cum- Chairman State Level Nalwar & Suket Devta Fair Committee Sundernagar** intends to invite sealed tenders in two bid system (Technical bid and Financial bid) from the bidders for "**Letting out space for setting up temporary Mela Shops 300 plus, Tambola and Rehdi Fari etc. in Jawahar Park at Sundernagar for State Level Nalwar & Suket Devta Fair-2024** " scheduled to be organized w.e.f. 22 to 28.03.2025 and from 02 to 06-4-2025 from experienced & registered vendors/ event managers having experience of construction/installation of such Water Proof Shops & turnover not less than Rs.01.00 Crore (One Crore) per annum during any three years of 10 years and having experience of construction/installation of such **setting up water proof temporary Mela Shop** at least three international fairs or equivalent events Preference will be given to the experienced managers/registered vendors who have their own Hangers/Domes material.

Such vendors who fulfil the aforesaid criteria can obtain detailed tender documents from the office of **Sub Divisional Magistrate –Cum- Chairman State Level Nalwar & Suket Devta Fair Committee Sundernagar, District Mandi (H.P.)** on cash payment of Rs 5,000/ (Rs. Five Thousand only) on any working day. The Tender documents duly filled in all respect must reach in the office of **Superintendent at this office** latest by 02nd March, 2025 up to 05:00 PM any tender, which is received after due date & time shall not be considered. The tender shall be opened same day at 2:00 PM before appropriate committee.

The tenderer are required to submit the tender applications/ documents in **(in two bid system -Technical bid and Financial bid)** a sealed cover envelopes marked as "**Tenders for setting up water proof temporary Mela Shop during State Level Nalwar & Suket Devta Fair-2025**".

INSTRUCTIONS TO THE TENDERERS

The tenderer are required to submit the tender applications/ documents (in two bid system- **Technical bid and Financial bid**) in sealed cover envelopes marked as " **Temporary mela shop's during State Level Nalwar & Suket Devta Fair 2025** " containing two separate envelopes. One envelope shall contain "Technical Bid" and second envelope shall contain "Financial Bid". Both of these envelopes shall be marked as "Technical Bid" and "Financial Bid separately.


1. **Technical Bid Envelope:** This envelope shall contain Tender form, undertaking (Annexure E & F) and terms and conditions of the tender (Annexure B) and duly signed self attested copies of following documents

- Valid registration certificate issued by competent authority.
- Experience Certificate/affidavit of self declaration, of three years.
- GST No.
- PAN.
- Proof of Identity and/or Proof of Address i.e. Voter Id Card Aadhar Card, Driving License.
- In case of Partnership firm copy of Partnership Deed.
- Earnest Money Deposit as prescribed in tender notice i.e. Rs. 15,00,000/- (Fifteen Lakh Rupees Only) may be attached in the shape of Demand Draft in favour of Chairman (SDM) State Level Nalwar Fair Sundernagar.
- The Technical Bid Envelope shall be opened on the date of opening of tender.

2. **Financial Bid Envelope:** This envelope shall contain Annexure "D" of amount offered. The Financial Bid shall be opened of the technically qualified bidders/tenderer only after the open auction. The financial bids of technically rejected bidders shall not be opened.

OTHER TERMS AND CONDITIONS

1. The Tender without earnest money will summarily be rejected.
2. The reserve price for the area shall be 80,000,00/- (Eighty Lakh) the bid will start from base price mentioned above.
3. Only those bidders are eligible who have annual turnover not less than Rs 1 Crore (Two Crore) per annum during last three years and have already executed at least three similar work in State/National/International level fair. The bidder will have to enclose experience certificate/ affidavit/self-declaration in this regard along with the bid.
4. successful bidder shall issue ID cards to the traders which shall be displayed on the person who is sitting in the shop In case of failure the security (EMD) of bidder shall be forfeited One copy of ID cards be deposited with the Mela Committee.
5. The bidder shall be required to deposit Rs.15.00 Lakh (Fifteen Lakh) as earnest money by way of FDR/Demand Draft payable in favour of Chairman (SDM) State Level Nalwar Fair Sundernagar. This amount shall be released to unsuccessful bidders, other than the second and third highest bidders immediately after the Tender/work is awarded in favour of the successful bidder Earnest Money deposited by the second and third highest bidders shall be released to them on 20th March, 2025 and of successful bidder on 15th April or before on

showing GST payment proof.

6. The Earnest Money deposited by the successful bidder shall be treated as **Performance Security Deposit** and this amount shall be released after the successful completion of the work to the satisfaction of the Convener, Ground Allotment Committee of **Sub Divisional Magistrate – Cum- Chairman State Level Nalwar & Suket Devta Fair Committee Sundernagar**. The above said amount shall stand forfeited in case the successful bidder fails to execute the work and comply any terms & conditions of the tender.
7. The successful bidder shall be required to **deposit 50%** of the bid amount within 3days of awarding of Tender in his/her favour, next remaining amount 50% by 17th March, 2025 .The above said payments shall be made by way of Demand Draft payable to the **Chairman (SDM) State Level Nalwar Fair Sundernagar**. Non depositing of amount by due date shall result in cancellation of contract and forfeiture of Earriest Money and the entire amount deposited by the defaulter bidder till date and the contract shall be awarded to the next highest bidder if the difference of bid amount is less then 10.00 (Ten Lakh)
8. **GST and other taxes as applicable shall be paid by the bidder only, undertaking against the same shall be submitted by the bidder along with the application on affidavit.**
9. The water proof Shops shall be erected strictly as per "INDIAN STANDARD RECOMMENDATIONS FOR THE FIRE PRECAUTION MEASURES IN CONSTRUCTION OF TEMPORARY SHOPS, STRUCTURES ."
10. There shall be no digging/excavation in Jawahar Park for the erection of any kind of structures. Proper drainage system shall be adopted Successful bidder shall ensure that no damage is caused to the Jawahar Park surface.
11. The layout of temporary shops should be as per map/site plan approved by the of **Sub Divisional Magistrate –Cum- Chairman State Level Nalwar & Suket Devta Fair Committee Sundernagar** and space as well as all the paths/roads shown in the map are necessary and any kind of violation shall be viewed seriously. However, any kind of minor changes in the layout (plan/map) shall be permissible with the prior permission of the Mela Committee.
12. The successful bidder shall ensure that eateries shops,no waste water and left out food articles be allowed to be scattered in and around Jawahar Park Proper Dust Bins be kept in every eateries shop and one Dust Bin for every five shops (50Ltr) in case of other shops and the successful bidder shall also ensure the regular cleaning of shops by deploying adequate number of Sweepers.
13. The successful bidder shall ensure that no plastic waste shall be thrown here and there and there shall be safe storage of the same..
14. The successful bidder shall ensure that all safety measures such as **Structural Safety, Fire Safety proper ventilation, adequate entry and exit, Safe Electric Supply** and such other Safety Measures as will be indicated by Ground Management Committee Further the bidder shall take Safety Certificate from the Safety Committee and shall comply with all Safety requirements desired by the Safety Committee and Ground Management Committee No any inflammable material will be stored in the Mela premises by the successful bidder or traders.
15. The successful bidder/traders shall obtain temporary electricity connections from the H.P. State Electricity Board Ltd. in respect of shops **and the electricity charges shall be paid by them**. Sufficient light arrangements be made in these structures by the bidder.
16. After the successful completion of the Mela the successful bidder shall vacate the space i.e. Jawahar Park let out to him/her of else action will be initiated and also fine be imposed i.e. 25000 per day.
17. If any time any question of difference or dispute whatsoever arises between the parties or in relation to a part thereof, either of the party may give to other notice in writing of the existence of such a question or dispute or difference and if required same shall be referred for arbitration to **Deputy Commissioner Mandi District Mandi H.P.** be binding upon both the parties.
