These both envelopes shall be marked as "Technical Bid" and "Financial Bid" separately and then be kept in a big envelope.

#### **OTHER TERMS AND CONDITIONS:-**

- 1. The quotation without earnest money will summarily be rejected.
- 2. Only those fabricators are eligible who have already executed at least three similar works in State/National level fair. The bidder/fabricator will have to enclose an affidavit/self-declaration/certificate in this regard along with the Tender. The Tender without such affidavit/self-declaration/certificate will be summarily rejected.
- 3. The floor of the stalls is to be covered with ply board having battens for drainage purpose. The entire area of the Exhibition should be covered with flooring and carpeting.
- 4. Main Gate and Exit Gate of width 12 feet and height 13 feet with complete decoration are to be provided. The gates are to be provided with proper locking arrangement after closing of Mela every night.
- 5. The fabricator has to fabricate stalls fully water proof and fully furnished in all respect.
- 6. Whole area including floor area of stalls should be covered with carpet.

- 7. Two tables and four chairs are to be provided per stall and 15 extra chairs have also to be provided and chairs and tables must be neat and clean.
- 8. All the stalls and open area to be illuminated/decorated with lighting, each stall is to be provided with one bulb and one bulb/LED/CFL light equivalent to 100 watts, one 5 Amp socket and outskirts should be decorated with lights and cloths.
- 9. The fabricator has to obtain the temporary electric connection required for the above purpose in the name of the Chairman, Nalwar Mela Committee- Sundernagar. However, the security amount and electricity bill amount will be borne by the Committee.
- 10. Regular Safe Drinking Water Facility (Aqua Guard) is to be provided at one place in the area.
- Two full time laborers for looking after the maintenance of stalls and electrification and one Sweeper be deputed.
- 12. The infrastructure should be complete in all respect by 20th March, 2025 by 5-00 P.M.
- 13. Rates should be inclusive of GST and rate per square meter also be mentioned. Taxes as applicable will be deducted from the bill.
- 14. No advance payment will be given to the fabricator till the installation is complete.
- 15. Work at site is to be started by 15<sup>th</sup> of the March, 2025. And completed by 20<sup>th</sup> March evening.
- 16. Fire Safety measures should be there at site (Two Fire Extinguisher with sufficient capacity) each stall.
- 17. All Safety measures must be incorporated for electrification.
- 18. If the fabricator fails to start the work by 15th of the March, 2025 the performance money will be forfeited.
- 19. Affidavit regarding the readily availability of infrastructure is to be provided by the fabricator.
